CONTRIBUTION AND PROCEDURE

According to § 7 section 2 of the statutes "Perspectives for Nigeria" e.V., the following contribution regulations apply from 28.08.2016 for the members of "Perspectives for Nigeria" e.V.

1. Contribution/Obligation

The members of the association have to pay the following annual fees:

- Active members: € 30,00
- Active members with reduced contributions: € 10,00
- Family contribution (with one member): € 45,00
- Company members (with one member vote): € 75,00

WE WOULD APPRECIATE IF THE PAYMENT WILL BE IN THE FIRST QUARTER OF THE YEAR

2. Contribution/Exemption

Free of charge are:

- Voluntary members from the beginning of their appointment
- Sisters of the DDL Congregation as long as they work for the Association: Perspectives for Nigeria

3. Contribution/Reduction

In the following cases, the contribution will be reduced to € 10.00 per year upon request and upon proof of the corresponding requirements vis-à-vis the office.

- Teenagers younger than 18 years (16-18 years).
- Trainees, pupils and students younger than 27 years against unsolicited proof of continuing (school) education / continuing studies until 01.02. or 01.08. every year.
- In cases of social hardship upon application and after approval by the Executive Board for one calendar half-year each.

If there is no proof, the full adult contribution will be charged and if the proof is submitted late, it will not be reimbursed.

4. Family contribution

Members of a family, who are members of the association, can claim the family contribution upon application and proof of the following requirements. If the application is made within one calendar

year, payments already made by the family members will be credited towards the family contribution.

A family is defined as no more than two adults living in a household with those underage children for whom at least one of the adults has at least joint custody.

The leadership of the common household and the custody are to be proved unsolicited.

5. New admission, termination and personnel changes

When joining the Association, the annual fee will be charged.

Resignation is to be reported in writing to the Managing Board (Perspektiven für Nigeria e.V., c/o Msgr. Heinz-Peter Teller, Katholische Kirchengemeinde Sankt Remigius Opladen, An St. Remigius 7, 51379 Leverkusen) - in the case of minors, with the consent of a legal representative. It is only possible with a notice period of three months to the end of the calendar year. In the event of termination before the end of a calendar year, no pro rata reimbursement of contributions already made will take place. Unpaid contributions remain due. This applies regardless of the time of termination or resignation.

Personnel changes (private address, bank details, marital status), we ask the Association's office to notify immediately.

6. Contribution/Collection

The annual contributions are collected in the Direct Debit Procedure.

Newly registered members will receive a written confirmation of admission not later than one week before moving in.
